


Record and Track COVID-19 Mortality Incidents Faster




Key Features



This module provides facility to capture all details of a decedent who has been confirmed with or suspected to have died from COVID-19. The information comes in from a medical facility, law enforcement office or funeral home.

The medico-legal investigator can then review the details of the case, speak to the attending doctor, the reporter or the Next of Kin (NOK). The investigator will add NOK, record if death is from COVID-19, and captures the medical history and a case synopsis. Then the investigator will be able to refer the case to an ME.





The ME uses this module to record observations on critical parameters such as: cause and manner of death, presence of any comorbidity and gives the overall observations on the case. The ME will also be able to view the intake data and the investigators' observations.


